Water & Sewer Pump Station Generators

Background

The Department of Public Works is recommending that permanent on-site generators be installed at three locations: North Ave Standpipe located at 920 West Road, Lincoln Ash Willow (LAW) Lift Station located at 17 W. Willow and Sunset Knolls Lift Station at 801 S. Rt. 53. All of these locations have been affected by repeated power outages over the past years.

The Village has standardized on the Cummins generators after acquiring two Cummins generators through a bid several years ago. The generators have performed satisfactorily and Cummins has provided adequate support for the equipment. The Fleet Services staff has attended training to maintain the Cummins generators and it is more efficient for them to specialize in maintaining one manufacturers rather than multiple types of generators.

Cummins has provided a price that includes the generator in a sound attenuated enclosure, automatic transfer switch and delivery. The cost for a 20 kW diesel generator with 24 hour fuel tank for the North Avenue Standpipe is \$22,311.00. A diesel generator is being purchased for the North Avenue Standpipe because the closest gas main is more than a block away. The cost for a 20 kilowatt (kW) natural gas generator for the LAW Lift Station is \$19,059.00. The cost for a 20 kilowatt (kW) natural gas generator for the Sunset Knolls Lift Station is \$19,059.00. The quotes from Cummins do not include installation. The installation for the generators at North Ave Standpipe, LAW and Sunset Knolls Lift Stations and the LAW Lift Station Control Panel Upgrade Project will be bid together under separate contract.

Funds for the generators are budgeted in the Water and Sewer Capital Reserve Fund under Water Maintenance & Improvements (North Ave Standpipe), Pump Station Component Replacement (LAW Lift Station) and Lift Station Maintenance (Sunset Knolls Lift Station) in FY 2012B.

Recommendations

Please present this request for a waiver of bids and award of a contract to Cummins NPower, Hogkins, IL, in an amount not to exceed \$60,429.00 for the purchase of one natural gas generator and one diesel generator for approval by the Board of Trustees at their September 6, 2012 meeting.

INSURANCE

- (A) During the term of the contract, the contractor shall provide the following types of insurance in not less than the specified amounts:
 - 1. Commercial General Liability \$1,000,000.00 per occurrence, \$2,000,000.00 aggregate;
 - 2. Auto Liability Combined Single Limit Amount of \$1,000,000.00 on any contractor owned, and/or hired, and/or non-owned motor vehicles engaged in operations within the scope of this contract;
 - 3. Professional Liability \$2,000,000.00 (Required only where contracts are for professional services);
 - 4. Workers Compensation Statutory; Employers Liability \$1,000,000.00 (the policy shall include a 'waiver of subrogation'); and
 - 5. Umbrella Coverage \$2,000,000.00
- The aforementioned insurance requirements shall be fulfilled by the contractor by (B) maintaining insurance policies which name the Village, its officers, agents, employees, representatives and assigns as additional insureds (except on policies for professional liability and workers compensation). The contractor shall furnish to the Village satisfactory proof of coverage by a reliable company or companies, before commencing any work. Such proof shall consist of certificates executed by the respective insurance companies and filed with the Village together with executed copies of an Additional Insured Endorsement (Insurance Form CG2010 - 1985 version). Said certificates shall contain a clause to the effect that, for the duration of the contract, the insurance policy shall be canceled, expired or changed so as to the amount of coverage only after written notification 30 days in advance has been given to the Village.
- (C) The contractor shall require subcontractors, if any, not protected under the contractor's policies, to take out and maintain insurance of the same nature in amounts, and under the same terms, as required of the contractor.

CONTRACT FOR WATER & SEWER PUMP STATION GENERATORS EXHIBIT "A" (CON'T)

VENUE

The parties hereto agree that for purposes of any lawsuit(s) between them concerning the contract, its enforcement, or the subject matter thereof, venue shall be in DuPage County, Illinois, and the laws of the State of Illinois shall govern the cause of action.

INDEMNIFICATION

The contractor shall indemnify, defend and save harmless the Village of Lombard, its officers, agents, employees, representatives and assigns, from lawsuits, actions, costs (including attorneys' fees), claims or liabilities of any character, including, as allowed by law, liabilities incurred due to joint negligence of the Village and the contractor, brought because of any injuries or damages received or sustained by any person, persons, or property on account of any act or omission, neglect or misconduct of said contractor, its officers, agents and/or employees arising out of, or in performance of any of the provisions of the contract, including any claims or amounts recovered for any infringements of patent, trademark or copyright; or from any claims or amounts arising or recovered under the "Worker's Compensation Act" or any other law, ordinance, order or decree. In connection with any such claims, lawsuits, actions or liabilities, the Village of Lombard, its officers, agents, employees, representatives and their assigns shall have the right to defense counsel of their choice. The contractor shall be solely liable for all costs of such defense and for all expenses, fees, judgments, settlements and all other costs arising out of such claims, lawsuits, actions or liabilities.

OTHER CONTRACTOR RESPONSIBILITIES

The contractor shall be responsible for complying with all applicable Federal, State, County and Village laws and regulations in the performance of the contract.
