SUBJECT: Compost Bin Grant Program

DATE: October 23, 2008

Per the Committee's request, staff has prepared the attached draft policy for a Compost Bin Grant Program. As with the Rain Barrel Grant Program, this program would be funded from the Village's service fee that is collected per the Solid Waste Contract as provided below:

Section 14 C(1) Village Service Fee:

In addition to the foregoing charges for Commercial properties, each multi-family residential Commercial customer/account shall be charged a Village Service Fee of \$0.10 per unit per month, and each non-multi-family residential Commercial customer/account shall be charged a Village Service Fee of \$3.00 per month. The Village reserves the right to increase the Residential and Commercial Village Service Fees. When an increase in the Residential and Commercial Village Service Fees is needed, the Village will take the proposed increase to the Environmental Concerns Committee for recommendation and to the Village President and Board for approval.

This fee wholly funds the Education Recycling Grants, Commercial Recycling Grants and Rain Barrel Grants. The approved budget for all Recycling Grants in FY 08-09 is \$29,000. The following grants have been encumbered thus far in the current fiscal year:

Recommendation:

Staff recommends that the Committee consider establishing the attached draft Compost Bin Grant Program to reimburse each homeowner up to \$80 to install one compost bin. Staff proposes to start this program in FY 09-10 (6/1/09) at a budget amount of \$5,000. A positive recommendation by the Committee would be forwarded to the Board of Trustees during the forthcoming budget discussions.

I. Purpose
The purpose of the Compost Bin Grant Program is to promote the on-site recycling of landscape waste to reduce the volume collected from single family residential properties.
II. Procedures/Guidelines
A. All owners of single family residences in the Village of Lombard are eligible for 100% reimbursement for one compost bin at a cost not to exceed \$80. All compost bins and their use shall comply with the Lombard Code of Ordinances, Title IX, Chapter 92 "Composting".
B. Grant applications shall be submitted to the Department of Public Works along with a copy of the store receipt and a photo of the installed bin. Public Works shall evaluate the grant application and shall verify correct installation of the bin prior to approving the grant.
C. Upon successful completion of the work and final inspection, the Village will reimburse the applicant per the Village's standard check mailing procedure.
D. Reimbursement is on a first-come, first-served basis, subject to the annual budget approved by the Village Board of Trustees in the Capital Improvement Program.
E. The compost bin shall be maintained by the property owner, not the Village of Lombard.

COMPOSTING

§ 92.40 PURPOSE AND INTENT

The purpose and intent of this Chapter is to promote the recycling of landscape waste through composting, and to establish minimum standards for composting.

§92.41 DEFINITIONS

For purposes of this Chapter, the following words and terms shall be defined as follows:

- (A) "Compost" shall be defined as the humus-like product of the process of composting landscape waste, which may be used as a soil conditioner.
- (B) "Composting" shall be defined as the biological treatment process by which microorganisms decompose the organic fraction of landscape waste, producing compost.
- (C) Compost Bin" shall be defined as an enclosure constructed of concrete blocks, brick, wood, woven wire or durable plastic which surrounds a compost pile.
 - (D) "Compost Pile" shall be defined as an area in which composting takes place.
- (E) "Landscape Waste" shall be defined as all accumulations of grass or shrubbery cuttings, leaves, tree limbs and other materials accumulated as the result of the care of lawns, shrubbery, vines and trees.

§92.42 STANDARDS AND CONDITIONS

- (A) All compost piles shall be enclosed in a free standing compost bin.
- (B) Each compost bin shall be no larger in volume than one hundred twenty-five (125) cubic feet, and shall be no taller than five (5') feet.
 - (C) No more than three (3) compost bin may be located on any lot used for residential purposes.
- (D) All compost bins/piles shall be maintained so as to prevent the attraction or harborage of rodents.
 - (E) All compost bins/piles shall be maintained so as to prevent unpleasant odors.
- (F) All composting shall be done in accordance with any process which has been found to be an acceptable composting process by the Illinois Department of Energy and Natural Resources.
 - (G) Compost piles shall only be made up of landscape waste.
 - (H) No compost pile/bin shall be located in any front yard or corner side yard.
- (I) A compost pile/bin may be located in a side yard provided, however, that it shall not be located in any side yard setback required by the zoning Ordinance.
- (J) A compost pile/bin may be located in a rear yard provided, however, that it shall not be located within three (3) feet of any lot line.


