

ORDINANCE NO. 6263

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES AND A NEW CLASS "A/B-IV" LIQUOR LICENSE CATEGORY

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "A/B-IV" liquor license category, to read in its entirety as follows:

"Class "A/B-IV" – Alcoholic beverages served as an adjunct to food service, with a gross annual dollar amount of liquor sales of more than \$400,000.00 (Restaurant). Package sales of specialty wine (wine produced under the name of a current or former professional sports figure) allowed from an on-premises gift shop associated with the restaurant. Package sales of specialty wine (wine produced under the name of a current or former professional sports figure) via phone/catalogue/internet order allowed, provided said sales are processed as a sale from the licensed premises."

SECTION 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein relative to the Class "A/B-III" liquor license to read in its entirety as follows:

"Class "A/B-III" - 17"

This reduction in the number of Class "A/B-III" liquor licenses reflects the termination of the Class "A/B-III" liquor licenses issued to HC Management Lombard, LLC d/b/a/ Harry Caray's Restaurant, located at 70 Yorktown Center, Lombard, Illinois.

SECTION 3: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "A/B-IV" liquor license category, to read in its entirety as follows:

"Class "A/B-IV" - 1"

That the Class "A/B-IV" liquor license, referenced in this Section, reflects the issuance of a Class "AB-IV" liquor license to HC Management Lombard, LLC d/b/a Harry Caray's Restaurant, located at 70 Yorktown Center, Lombard, Illinois.

SECTION 4: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "A/B-IV" liquor license category, to read in its entirety as follows:

"Class "A/B-IV" - \$3,000.00"

SECTION 5: That Title 11, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the reference therein to "all Class A/B-I, A/B-II, A/B-III, C, D, E-I, E-II, I, K, L, M, O-I, O-II, R, T-I, T-II, X and Z liquor license holders," to read, "all Class A/B-I, A/B-II, A/B-III, A/B-IV, C, D, E-I, E-II, I, K, L, M, O-I, O-II, R, T-I, T-II, X and Z liquor license holders."

SECTION 6: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


