

**ORDINANCE NO. 6315**

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112  
OF THE LOMBARD VILLAGE CODE IN REGARD TO  
ALCOHOLIC BEVERAGES AND THE CLASS "Y" LIQUOR LICENSE CATEGORY**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by relabeling the Class "Y" liquor license description as Class "Y-I."

**SECTION 2:** That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "Y-II" liquor license category, to read in its entirety as follows:

"Class "Y-II" Package sales of Shannon's private label wine by a butcher shop."

**SECTION 3:** That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein relative to the Class "Y" liquor license to read in its entirety as follows:

"Class "Y-I" - 1  
Class "Y-II" - 1"

**SECTION 4:** That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by revising the language therein relative to the Class "Y" liquor license to read in its entirety as follows:

"Class "Y-I" - \$500  
Class "Y-II" - \$500"

**SECTION 5:** That the current Class "Y" liquor license issued to Yorktown Deli, Inc., operating the business commonly known as Frankie's Deli at 4 Yorktown

Convenience Center, Lombard, Illinois, is hereby changed to a Class "Y-I" liquor license, as authorized in Section 3 above.

**SECTION 6:** That the Class "Y-II" liquor license, referenced in Section 3 above, reflects the issuance of a Class "Y-II" liquor license to Custom Wholesale Meat Packing, Inc., operating the business commonly known as Clancy's Corner Butcher Shoppe, located at 15 South Park Avenue, Lombard, Illinois.

**SECTION 7:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
