



**ORDINANCE NO. 6550**

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VIII (u) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS (school days between the hours of 7:30 a.m.-8:30 a.m. and 2:00 p.m.-3:30 p.m.) be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Charlotte St., east side	Pleasant Lane	To a point 385 feet South
Charlotte St., west side	Berkshire Ave.	To a point 385 feet North

Section 2: That Schedule VI of the Lombard Traffic Code (Ordinance 1186) entitled ONE-WAY STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>Direction of Traffic Movement</u>
Berkshire Ave. from Main St. to Charlotte St. between 8:00 a.m. and 4:00 p.m. on school days	East

Section 3: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
