

Notice of Proposed Property Tax Increase for the Village of Lombard

I A public hearing to approve a proposed property tax levy increase for the Village of Lombard for 2008 will be held on December 4, 2008 at 7:30 p.m. at the Lombard Village Hall, Village Board Room, 255 E. Wilson Avenue, Lombard, Illinois 60148.

II The corporate and special purpose property taxes extended or abated for 2007 were \$10,376,891.

The proposed corporate and special purpose property taxes to be levied for 2008 are \$11,016,317. This represents a 6.16% increase over the previous year.

III The property taxes extended for debt service and public building commission leases for 2007 were \$0.

The estimated property taxes to be levied for debt service and public building commission leases for 2008 are \$0. This represents a 0.00% increase over the previous year.

IV The total property taxes extended or abated for 2007 were \$10,376,891.

The estimated total property taxes to be levied for 2008 are \$11,016,317. This represents a 6.16% increase over the previous year.
