SUBJECT: Text Amendment to Title 11, Chapter 112, Section 112.13(A)

Number of Authorized Liquor Licenses

Rocco Food Group, Inc. d/b/a Rancho Viejo located at 708 S. Main St. currently holds an A/B-I liquor license which is effective through November 30, 2013.

Village Staff, through the liquor license renewal process, has made repeated attempts to contact the Licensee by both telephone and letter (see attached letter dated November 15, 2013) in order to determine if they intended to renew their liquor license as their renewal application and fee had not been received. The letter stated that if staff did not receive a reply by November 22, 2013, staff would interpret that to mean that they were not interested in renewing their liquor license. To date we have not received a response. Also, subsequent to the letter being sent, the DuPage County Health Department has "tagged" the business as "not approved for occupancy".

Due to the aforementioned reasons, staff has attached an ordinance decreasing the A/B-I liquor license classification by one to reflect the non-renewal of the liquor license by Rancho Viejo. Staff is requesting a waiver of first reading to bring the number of licenses available in the A/B-I classification current as their liquor license expired on November 30, 2013.

Dear Mr. Camacho:

Please be advised that the Village of Lombard has not received your Application for Renewal of Liquor License with the required documentation and fee for the December 1, 2013 to May 31, 2014 license period. The Lombard Village Code requires that a liquor licensee shall file an application for renewal of a liquor license accompanied by the appropriate license fee by the first day of November for this license period.

Due to the lack of response, I have left several telephone messages requesting that you contact me to state your intentions relative to your liquor license renewal. As of this writing, I have not received a reply.

Please be advised that this letter serves as notification that your current liquor license expires November 30, 2013. If the required documentation and fee \$550.00 (which includes a 10% penalty) are not received by November 22, 2013 the Village of Lombard will interpret this to mean that you no longer desire to renew your liquor license, and Rocca Food Group, Inc d/b/a Rancho Viejo must cease serving alcohol on December 1, 2013. Further, the Village Board of Trustees, at their December 5, 2013 meeting, will vote on an ordinance reducing the number of Class A/B-I liquor licenses by one, to reflect the non-renewal of your liquor license. If the Lombard Village Board takes such action, and, should you desire to obtain a liquor license in the future, you will be required to go through the entire liquor license application process.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended BY REVISING THE ENTRY RELATIVE TO THE Class A/B-I liquor licenses contained therein, to read as follows:

"Class A/B-I - 7"

Section 2: That the change in the number of Class A/B-I liquor licenses set forth in Section 1 above, is a result of Rocca Food Group, Inc. d/b/a Rancho Viejo no longer conducting business at 708 S Main St.
