Lombard Fire Department Citizen Assist Report September 24, 2012

On direction from the Lombard Village Board, the Fire Department will establish an Ordinance that charges a fee for Basic Life Support (BLS), non-transport services, for requests that total more than five per calendar year, per individual. Basic life support is defined as care that involves the treatment of non-life threatening injuries or illnesses, requiring only basic levels of care or services, which includes lift assists. The fee requested is \$100.00 per BLS non-transport service for the sixth and subsequent events per calendar year. Not only will this help recover a reasonable portion of resources used during these non-transport events, it will enable citizens to use provided resources to improve their quality of life. The Fire Department brought this before the Board of Trustees on February 3, 2011 and then again on March 1, 2012.

Background

The Lombard Fire Department continues to be one of the busiest ambulance companies in DuPage County. During the 2011 calendar year, the LFD responded to 4,593 ambulance calls. Invalid assist requests were at 293 during this period, representing 6% of all ambulance calls. Using 2012 call volume through September 30, we can project 312 invalid assists requests.

Citizen and Invalid assists are almost always; residents, elderly, or struggling with health problems such as M.S. or other debilitating diseases. Non-residents would rarely go over five invalid assist calls per year. Using 2011 data, 64 total calls could have been billed based on this Ordinance. Unfortunately, five citizens make up 59 of the 64 billable calls. The ability of these citizens (who call for invalid assists) to pay for services when they would be charged, is questionable. A waiver of fees will be at the discretion of the Village Finance Director and the Fire Chief.

Proposed Option

Frequent users will be monitored by the EMS Coordinator. Once a pattern of repeat usage is recognized, our contracted Social Services Agency, "Association for Individual Development" (AID) will be contacted. The representative will investigate options for a social service to intervene. These options may assist in the person's quality of life and healthcare needs if utilized by the citizen. With the permission of the patient, family members will also be contacted and informed of the increase in calls for services. Outside agency information will be supplied to the citizen, but it remains the citizen's decision to seek and accept help from those agencies.

The Village of Lombard wishes to remind residents that in case of an emergency, always dial 9-1-1. The Lombard Fire Department is the best resource for initial requests for services. We are part of a 9-1-1 system, staffed 24 hours per day and are able to arrive quickly with the resources to handle health and injury issues. In addition, our personnel are trusted by callers, trained to recognize abuse or neglect, and recognize other safety issues that may exist.

If the citizen appears to be unable to care for themself or is in an unsafe living condition, they will be reported to the Association for Individual Development (AID), the victim services agency contracted by the Village of Lombard, as soon as the LFD becomes aware of the situation. AID has made the difference on many occasions, such as; during a heat emergency in July of 2012, an elderly woman without power and no way to care for herself in the heat, was reported to AID. AID found temporary shelter for her and returned a call to the fire department notifying them. Another case involved an overdose patient. An unaware mother was very grateful to AID for their assistance and support.

The last example is an elderly woman living alone who was found to be in need of a Life Alert device. This patient's son was happy to be notified by AID and proceeded to purchase the Life Alert package for his mother. The LFD feels contact with frequent users can be used to help reduce request for services, and at the same time, improve quality of life.

Comparisons

All DuPage County Fire Departments have been contacted in reference to billing for invalid/citizen assists. Three DuPage County Fire Departments currently charge for these services. They are the Naperville Department, the Warrenville Fire Department and Tri-State Fire Protection District. It should be noted that Medicare/Medicaid will not cover the cost of invalid assists, as it is a non-transport service.

The three Fire Departments that charge do so as follows:

Naperville

- First and second assists; no charge.
- Three or more assists in a calendar year, \$50 each, resets January 1.
- If unable to pay, billing will set up payment plan. If still unable to pay, referred to Finance Department to decide if bill stands or is waived.
- Repeat users are referred to their Social Services Department.

Warrenville

- Three assists per month; no charge.
- \$100 each for more than 3 per month.

Tri-State Fire Protection District

- Resident, \$250 each occurrence.
- Non-resident, \$500 each occurrence.

Recommendation

The proposed option, captured in this document, which includes the Ordinance Amendment, focuses on individuals that may need more attention from their families and social services, thus bringing a better quality of life to them.

We know that responses made by the fire department to invalid assist calls allows paramedics to assess patients and their living conditions, concluding that it is indeed necessary for these individuals to dial 9-1-1 when necessary.

The Lombard Fire Department recommends this Ordinance Amendment and the continuation of social service intervention.

AN ORDINANCE AMENDING TITLE 9, CHAPTER 91, SECTION 91.21(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO FEES FOR EMERGENCY MEDICAL SERVICES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That Title 9, Chapter 91, Section 91.21 (A) of the Lombard Village Code is hereby amended by adding the following to the fee chart contained therein:
