**Number of Authorized Liquor Licenses – Class “A/B-II”**  
**DMK Burger Bar - 2370 S. Fountain Square Drive**

DMK Burger Bar 2 LLC d/b/a DMK Burger Bar located at 2370 S. Fountain Square Drive currently holds a Class “A/B-II” liquor license which allows them to serve alcoholic beverages as an adjunct to food service with no packaged sales. Staff received email confirmation from restaurant personnel that the business has ceased operations in Lombard.

Attached is an ordinance decreasing the Class “A/B-II” liquor license category by one as required by Village Code.

Staff is requesting a waiver of first reading in order to bring the number of licenses available in the Class “A/B-II” liquor classification current to reflect this change.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license category contained therein, to read as follows:

Class "A/B-II" - 8

Section 2: That the decrease in the number of Class "A/B-II" liquor licenses set forth in Section 1 above, is a result of DMK Burger Bar 2 LLC d/b/a DMK Burger Bar no longer conducting business at 2370 S. Fountain Square Drive, Lombard IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
