AND A JOINT REVIEW BOARD MEETING

Village staff, Counsel and Kane McKenna & Associates have been completing work relative to creating the proposed Second Amendment to the existing Butterfield-Yorktown Tax Increment Financing (TIF) District. The Second Amendment proposes to add four additional parcels to the TIF District and amend relevant sections of the original TIF Redevelopment Plan and Project.

Pursuant to State Statutes, the Village will be required to call a meeting of the Joint Review Board (JRB), with the JRB being comprised of representatives of the affected school districts, park districts, library district, York Township, DuPage County, the Village and the citizen member. Please find the attached Ordinance establishing a meeting of the JRB on Friday, August 7, 2020 at 2:00 p.m. in the Village Hall Board Room.

Also attached is the latest schedule of requisite activities to be undertaken relative to the proposed Second Amendment. When created, the schedule denoted a 3:00 p.m. start time to the JRB meeting. However, as the proposed JRB meeting will also cover the annual report reviews of all Village TIF Districts as well as the required hearing, the meeting time was moved ahead by one hour to 2:00 p.m., as set forth within the draft Ordinance.

RECOMMENDATION:

Staff recommends approval of the attached Ordinance. Staff also requests a waiver of first reading in order to provide adequate public notice to the JRB members and the public.

AN ORDINANCE CALLING FOR
A PUBLIC HEARING AND A JOINT REVIEW BOARD MEETING
TO CONSIDER THE EXPANSION OF
THE REDEVELOPMENT PROJECT AREA
FOR THE LOMBARD BUTTERFIELD-YORKTOWN
TAX INCREMENT FINANCING DISTRICT AND A SECOND AMENDMENT
TO THE AMENDED REDEVELOPMENT PLAN AND PROJECT
FOR THE LOMBARD BUTTERFIELD-YORKTOWN
TAX INCREMENT FINANCING DISTRICT IN RELATION THERETO

WHEREAS, pursuant to the Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 *et seq.* (hereinafter referred to as the "TIF Act") and Ordinance Numbers 7437, 7438 and 7439, adopted November 2, 2017, as amended by Ordinance Number 7451, adopted December 7, 2017, Ordinance Number 7705, adopted September 5, 2019 and Ordinance Number 7758, adopted December 5, 2019, the President and Board of Trustees (hereinafter referred to as the "Village Board") of the Village of Lombard (hereinafter referred to as the "Village") approved an amended tax increment redevelopment plan and project (hereinafter referred to as the "Amended TIF Plan"), designated the tax increment redevelopment project area (hereinafter referred to as the "Original Redevelopment Project Area" and legally described on Exhibit A attached hereto and made part hereof), and adopted tax increment financing relative to the Village's Butterfield-Yorktown Tax Increment Financing District (hereinafter referred to as the "B-Y TIF District"); and

WHEREAS, on January 9, 2020, the Village Board of the Village authorized, by motion, an eligibility study and the preparation of an amendment to the Amended TIF Plan relative to the proposed expansion of the Original Redevelopment Project Area for the B-Y TIF District; and

WHEREAS, on January 17, 2020, the Village published the Tax Increment Financing (TIF) Interested Parties Registry Notice, as required by Section 5/11-74.4-5(a) of the TIF Act, in the *Daily Herald*; and

WHEREAS, on June 18, 2020, the Village announced the availability of an amendment to the Amended TIF Plan for the B-Y TIF District (hereinafter referred to as the "Second Amendment to the TIF Plan"; and said Amended TIF Plan, as amended by the Second Amendment to the TIF Plan, being hereinafter referred to as the "Further Amended TIF Plan"), with said Second Amendment to the TIF Plan containing an amendment to the eligibility study for the B-Y TIF District, addressing the tax increment financing eligibility of the area proposed for addition to the Original Redevelopment Project Area (said amendment to the eligibility study being hereinafter referred to as the "First Supplement to the Eligibility Study"; said area proposed for addition to the Original Redevelopment Project Area being hereinafter referred to as the "Expansion Area"; and said Original Redevelopment Project Area as amended to include the Expansion Area being hereinafter referred to as the "Expansion Area"); and

WHEREAS, pursuant to the provisions of Section 5/11-74.4-5(c) of the TIF Act, prior to the adoption of the ordinance approving the Expanded Redevelopment Project Area and the Second Amendment to the TIF Plan for the B-Y TIF District, the Village must fix a time and place for a public hearing; and

WHEREAS, pursuant to the provisions of Section 5/11-74.4-5(b) of the TIF Act, prior to the adoption of the ordinance approving the Expanded Redevelopment Project Area and the Second Amendment to the TIF Plan for the B-Y TIF District, the Village

must convene a meeting of the Joint Review Board (hereinafter referred to as the "JRB") to consider the proposal; and

WHEREAS, it is the desire of the Village Board of the Village to conduct such public hearing and to convene said meeting of the JRB;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That, pursuant to the provisions of the TIF Act, the Village Board hereby designates the date of Thursday, September 17, 2020, at the hour of 7:00 p.m. at the Lombard Village Hall, Village Board Room, 255 East Wilson Avenue, Lombard, Illinois, for the purpose of conducting a public hearing to hear from any interested persons, taxpayers or affected taxing districts regarding the proposed Expanded Redevelopment Project Area and the Second Amendment to the TIF Plan for the B-Y TIF District; said Expansion Area, being legally described on Exhibit B attached hereto and made part hereof, and said Expanded Redevelopment Project Area being legally described on Exhibit C attached hereto and made part hereof.

SECTION 2: That copies of the First Supplement to the Eligibility Study and the proposed Second Amendment to the TIF Plan for the B-Y TIF District have been on file in the office of the Village Clerk, and have been available for public inspection during regular Village business hours, since June 18, 2020.

SECTION 3: That at the public hearing, any interested person, taxpayer or affected taxing district may file with the Village Clerk written comments and/or objections to, and may be heard orally with respect to, any issues embodied in the notice of public hearing attached hereto.

SECTION 4: That the JRB for the B-Y TIF District, as previously established, shall meet on Friday, August 7, 2020, at 2:00 p.m. at the Lombard Village Hall, Village Board Room, 255 East Wilson Avenue, Lombard, Illinois. The JRB shall review the public record, planning documents, the First Supplement to the Eligibility Study, the Expansion Area, the Expanded Redevelopment Project Area, the Second Amendment to the TIF Plan, and the proposed ordinances approving the Expanded Redevelopment Project Area and the Further Amended TIF Plan for the B-Y TIF District. The JRB shall make an advisory recommendation to the Village within thirty (30) days after the convening of the JRB. A written report shall be issued by the JRB. The failure of the JRB to submit its report on a timely basis shall not be cause to delay the public hearing or any other step in the process of designating the Expanded Redevelopment Project Area and approving the Second Amendment to the TIF Plan for the B-Y TIF District. In the event the JRB does not file a report, it shall be presumed that the JRB has approved the matters before it. Pursuant to the provisions of Section 5/11-74.4-5(b) of the TIF Act, the JRB consists of one (1) representative from each of the following taxing districts: College of DuPage Community College District No. 502; Glenbard Township High School District No. 87; DuPage High School District No. 88; Villa Park School District No. 45; DuPage County Elementary School District No. 44; DuPage County; York Township; the Lombard Park District; York Center Park District; Helen M. Plum Library District; the Village of Lombard (current member Keith Giagnorio, Village President, who serves as chairperson of the JRB); and a public member (the current public member is John Dillon).

SECTION 5: That the Village of Lombard's representative on the JRB is hereby reconfirmed as the Village President, or his designee.

SECTION 6: That a notice setting forth the availability of the First Supplement to the Eligibility Study and the Second Amendment to the TIF Plan for the B-Y TIF District, and how to obtain a copy thereof, shall be sent by mail to all residential addresses within seven hundred fifty (750) feet of the boundaries of the B-Y TIF District and to all persons who have registered on the Village's TIF Interested Parties Registry, within a reasonable time after the adoption of this Ordinance, as required by Section 5/11-74.4-5(a) of the TIF Act, with said notice being substantially in the form attached hereto as Exhibit D and made part hereof.

SECTION 7: That a notice of the public hearing and the JRB meeting shall be sent by certified mail, return receipt requested, and a notice of the public hearing shall be given by publication, certified mail, return receipt requested, and by first class U.S. Mail, all as required by Sections 5/11-74.4-5(b) and 5/11-74.4-6(a), (b) and (c) of the TIF Act, with said notices being substantially in the form attached hereto as <u>Exhibit E</u> and made part hereof.

SECTION 8: That this Ordinance shall be in full force and effect from and after its adoption and approval as provided by law.
