

ORDINANCE NO. 6072

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112  
OF THE LOMBARD VILLAGE CODE IN REGARD TO  
ALCOHOLIC BEVERAGES AND THE CLASS "O" LIQUOR LICENSE CATEGORY**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by revising the language therein relative to the Class "O" liquor license to read in its entirety as follows:

"Class "O-I" Alcoholic beverages served for consumption on the premises of a hotel, exhibition hall or convention hall.

Class "O-II" Beer and wine only served for consumption on the premises of a hotel, exhibition hall or convention hall."

**SECTION 2:** That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein relative to the Class "O" liquor license to read in its entirety as follows:

"Class "O-I" - 2  
Class "O-II" - 1"

**SECTION 3:** That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein relative to the Class "C" liquor license to read in its entirety as follows:

"Class "C" - 1"

**SECTION 4:** That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by revising the language therein relative to the Class “O” liquor license to read in its entirety as follows:

“Class “O-I” - \$2,000  
Class “O-II” - \$1,000”

**SECTION 5:** That Title 11, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the reference therein to “all Class A/B-I, A/B-II, A/B-III, C, D, E-I, E-II, I, K, L, M, O, R, T-I, T-II, X and Z liquor license holders,” to read, “all Class A/B-I, A/B-II, A/B-III, C, D, E-I, E-II, I, K, L, M, O-I, O-II, R, T-I, T-II, X and Z liquor license holders.”

**SECTION 6:** That the current Class “O” liquor licenses issued to Djont/EPT Leasing, LLC, operating the business commonly known as Embassy Suites Hotel, located at 707 East Butterfield Road, Lombard, Illinois, and to Westin Hotel Management, L.P., operating the business commonly known as Westin Lombard Yorktown Center, located at 70 Yorktown Center, Lombard, Illinois, are hereby changed to Class “O-I” liquor licenses, as authorized in Section 2 above.

**SECTION 7:** That the reduction in Class “C” liquor licenses, referenced in Section 3 above, reflects the termination of the Class “C” liquor license issued to Select Hotels Group, LLC, operating the business commonly known as Hyatt Place, located at 2340 South Fountain Square Drive, Lombard, Illinois.

**SECTION 8:** That the Class “O-II” liquor license, referenced in Section 2 above, reflects the issuance of a Class “O-II” liquor license to Select Hotel Group, LLC, operating the business commonly known as Hyatt Place, located at 2340 South Fountain Square Drive, Lombard, Illinois.

**SECTION 9:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.




