
Both Walgreens Store locations are requesting a liquor license for package sales. An Ordinance increasing the Class H liquor license category is recommended for approval.

ORDINANCE

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTIONS 112.13 AND 112.35 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC LIQUOR

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class H liquor license category, contained therein, to read as follows:

“Class “H” - 4”

Section 2: That the change in the number of Class H liquor licenses, as provided for in Section 1 above, is a result of the issuance of Class H liquor licenses to Walgreen Company d/b/a Walgreens #9217 located at 309 W. St. Charles Road, Lombard and to Bond Drug Company of Illinois LLC d/b/a Walgreens #4780 located 225 E. Roosevelt Road, Lombard.

Section 3: That Title 11, Chapter 112, Section 112.35 of the Lombard Village Code is amended by deleting the words, “or “H”” therefrom.

Section 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
