Subject: Electricity Supply Contract

The Village Board was polled through the Manager's Notes to authorize the Northern Illinois Municipal Electric Cooperative (NIMEC) to serve as the broker for the Village in regard to obtaining bids from electricity providers for the period of June 2009 through May 2012 and authorizing the Village Manager to approve a contract with the lowest cost electricity provider.

Bidding was conducted by NIMEC on August 12, 2008, for the electrical needs for the Village's water and sewer system for the period of June 2009 through May 2012. The winning bid was submitted by Exelon Energy Company. The bid rate varies by account (the Village has eight accounts that were included in the bid). However, based on current usage, the bid rate would result in decrease in cost of 11.8% compared with the rate that is being paid for June 2008 through May 2009. This rate will be fixed for the entire three years of the contract.

As Exelon is our current provider of electricity for the water and sewer system, the attached exhibits amend the original contract which was ratified by the Board on April 3, 2008 to display the new pricing. In accordance with the authorization provided for by the Board, the contract was executed on August 13, 2008. As there was no Board meeting since we became aware of this bid, the resolution authorizing the Village Manager to execute this contract is also on the agenda for the August 21^{,2}008 Board meeting. In accordance with this resolution, the contract is to be placed on the first available Village Board meeting following the execution thereof by the Village Manager for ratification by the President and Board of Trustees.
