The Village has received a request for a Class “C” liquor license from Tereneo 3634 LLC d/b/a Bat 17 located at 2770 S. Highland Avenue, Suite 102. The Class “C” liquor classification allows beer and wine to be served as an adjunct to food service with no package sales allowed. Bat 17’s menu is currently offering deli sandwiches, burgers, salads and vegan options.

Attached is an ordinance increasing the Class “C” liquor license category by one, and issuing a Class “C” liquor license to Tereneo 3634 LLC d/b/a Bat 17. The petitioner is requesting a waiver of first reading in order to have the ability to offer liquor service as soon as possible.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:**

Section 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 8

This increase in Class "C" liquor licenses reflects the issuance of a Class "C" liquor license to Bat 17 who will be operating the business commonly known as Tereneo 3634 LLC d/b/a Bat 17 located at 2770 S. Highland Avenue, Suite 102, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
