Subject: Resolution authorizing the payment of the Illinois Municipal Retirement Fund

Early Retirement Incentive Program 2013 estimated employer costs in the amount

of \$2,089,983.22.

On December 6, 2012 the Village Board authorized the implementation of an early retirement incentive program ("ERI") offered through the Illinois Municipal Retirement Fund ("IMRF"). In order to avoid interest charges on the 2013 ERI costs, staff is recommending that the estimated 2013 employer cost of \$2,089,983.22 be issued prior to December 31, 2013 (Attachment 1). Another payment will be made in 2014 to IMRF for the remaining costs associated with the ERI program.

## **RECOMMENDATION:**

Staff is recommending Board approval of a Resolution authorizing the payment of the 2013 estimated employer costs for the Illinois Municipal Retirement Fund-Early Retirement Incentive Program liability in the amount of \$2,089,983.22.
