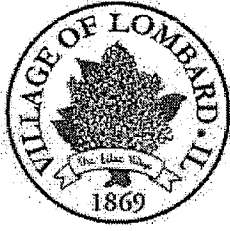

**BACKGROUND**

The Tri-Town YMCA has recently submitted an application to place banners advertising their annual **Golf Outing**. The YMCA is requesting approval of the use of public right-of-way for temporary banner signs. The specific location of the sign would be the southeast corner of Main Street and Wilson Avenue

The sign would be approximately 24 square feet in area. The sign would be placed at the specified location on or around June 8, 2012 and would be removed on or about June 15, 2012.

**RECOMMENDATION**

Staff recommends that the Village Board grant the Tri-Town YMCA authority to use the public right-of-way for temporary signage for their **Golf Outing**.
