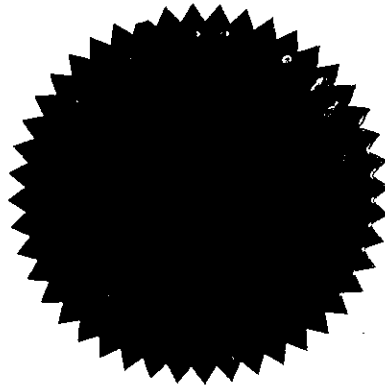

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "M" liquor license, contained therein, to read as follows:

Class "M" - 0

This decrease in Class "M" liquor licenses reflects the sale of the assets of Ogden Entertainment, Inc./I & S Consultants, Inc. and the termination of the Class "M" liquor license issued to Ogden Entertainment, Inc./I & S Consultants, Inc. d/b/a Enchanted Castle in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "M" liquor license, contained therein, to read as follows:

Class "M" - 1

This increase in Class "M" liquor licenses reflects the issuance of a Class "M" liquor license to Alfa SmartParks, Inc./I & S Consultants, Inc. who will be operating the business commonly known as Enchanted Castle, 1103 S. Main Street, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.


