

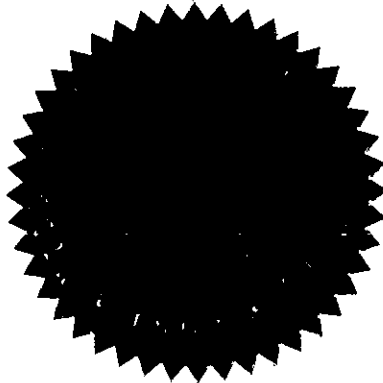

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VIII(m) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS between the hours of 9a.m.-3p.m. on school days be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Lincoln Street East & West side	South curb line of Harding Road	North curb line of Wilson Road

Section 2: That Schedule VIII(m) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS between the hours of 9a.m.-3p.m. on school days be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Lincoln Street East & West side	Harrison Road	Wilson Road

Section 3: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Harding Road North side	East curb line of Main Street	West curb line of Charlotte Street
Grove Street North side	East curb line of Main Street	West curb line of Charlotte Street
Grove Street South side	105 feet east of the east curb line of Main Street	a point 165 feet east
Wilson Avenue North and south sides	East curb line of Westmore/Meyers Road	a point 130 feet east

Section 4: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Harding Road North side	Main Street	Hammerschmidt Avenue

Section 5: That Schedule X(a) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS for a period of time exceeding one hour between the hours of 7a.m. and 10a.m. on any day except Sundays and holidays be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Grove Street Both sides	Charlotte Street	Martha Street
Grove Street North side	Martha Street	Elizabeth Street
Grove Street South side	Elizabeth Street	Lincoln Street

Section 6: That Schedule X(a) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS for a period of time exceeding one hour between the hours of 7a.m. and 10a.m. on any day except Sundays and holidays be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Grove Street South side	East curb line of Elizabeth Street	a point 105 feet east of the east curb line of Main St.
Grove Street South side	165 feet east of the east curb line of Main St.	West curb line of Martha Street
Grove Street North side	West curb line of Martha Street	East curb line of Charlotte Street
Grove Street North side	West curb line of Main St.	East curb line of Elizabeth Street

Section 7: That Schedule X(f) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS between the hours of 7a.m. and 10a.m. on any day except Sundays and holidays be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>

Section 8: That Schedule X(f) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS between the hours of 7a.m. and 10a.m. on any day except Sundays and holidays be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Ash Street North side	East curb line of Elizabeth Street	West curb line of Lincoln Avenue

Section 9: That Schedule X(o) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS between the hours of 6a.m. and 9a.m. Monday-Friday, except Holidays be amended to add in its entirety as follows:

“(o) In accordance with Section 10-13-10 and when signs are erected giving notice thereof, no person shall park a vehicle between the hours of 6a.m.-9a.m., Monday-Friday, Except Holidays in any of the following places:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Ash Street North side	West curb line of Main Street	East curb line of Lincoln Avenue

Section 10: That Schedule XIII of the Lombard Traffic Code (Ordinance 1186) entitled RIGHT TURNS ON RED TRAFFIC SIGNALS be amended to add the following thereto:

i) All four corners: Main Street and 16th Street, when pedestrians are present.

Section 11: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
