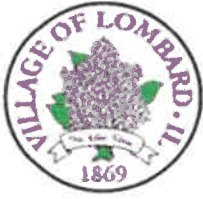

Aldi, Inc d/b/a Aldi  
205 W. Roosevelt Road**

The Village received a request for a Class “GG” liquor license from Aldi, Inc. d/b/a Aldi located at 205 W. Roosevelt Road, for the July 1 - December 31, 2023, license term.

Aldi is a well-known grocery establishment offering consumers a variety of grocery needs and has become a staple in many areas including DuPage County. There are currently two Aldi locations just East and West of the new location, in Villa Park and Glen Ellyn, respectively. Adding the new Lombard location will open more opportunities for the residents to shop locally. Aldi, Inc. is looking to add the retail sales of Beer and Wine to the shopping experience.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) increasing the Class “GG” liquor license category by one and granting a liquor license to Aldi, Inc. d/b/a Aldi located at 205 W. Roosevelt Road.

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF CLASS "GG" LIQUOR LICENSES**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein, relative to the Class "GG" liquor license category, to read in its entirety as follows:

"Class "GG" – 2"

This increase in the number of Class "GG" liquor licenses reflects the issuance of a new Class "GG" liquor license to Aldi, Inc. d/b/a Aldi, located at 205 W. Roosevelt Road, Lombard, Illinois.

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
