**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,  
SECTION 112.12(A) OF THE LOMBARD VILLAGE CODE  
IN REGARD TO ALCOHOLIC BEVERAGES AND  
THE CLASS "O" LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title XI, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by revising the second sentence, of the language contained therein, relative to the description of the Class "O" liquor license category, to read in its entirety as follows:

"Packaged goods sales of beer, wine and single-serving (12 oz./355 ml.) pre-mixed cocktails, to patrons of the hotel, shall also be allowed, provided all beer, wine and single-serving pre-mixed cocktails on display for sale shall be kept in a locked display case, with only the cashier being able to unlock said display case."

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
