ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class O" liquor license, contained therein, to read as follows:

Class "O" - 2

This decrease in Class "O" liquor licenses reflects the termination of Stanhope LLC d/b/a Hyatt Place and the termination of the Class "O" liquor license issued to Stanhope LLC in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "O" liquor license, contained therein, to read as follows:

Class "O" - 3

This increase in Class "O" liquor licenses reflects the issuance of a Class "O" liquor license to Select Hotels Group, LLC who is operating the business commonly known as Hyatt Place Lombard located at 2340 S. Fountain Square Drive, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
