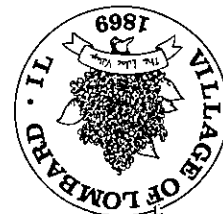

Subject: FY07 vehicle purchase

The FY 2007 budget includes the purchase of three(3) Ford Explorers for the fire department. State bid for this type of vehicle has been awarded to Landmark Ford of Springfield, IL. The cost of each unit is \$20,072 or \$60,401 for three(3) with one set of repair manuals. The budgeted amount for these three(3) vehicles is \$25,000 each or a total of \$75,000.
