3DH Hospitality LLC d/b/a Humo Smokehouse 1000 N. Rohlwing Road, Suite 13, Lombard, IL

The Board of Trustees recently passed Ordinance 8233 on January 4, 2024, revising the Class "XX-VG" liquor license classification, and issuing a license to 3DH Hospitality LLC d/b/a Humo Smokehouse, 1000 N. Rohlwing Road, Suite 13, Lombard, IL for the January 1 - June 30, 2024, license term.

Village staff received verbal notification, via an in-person meeting, on May 1, 2024, from the owners of Humo Smokehouse that effective April 26, 2024, that they are no longer open for business.

Pursuant to Title XI, Chapter 112, Article II, Section 112.12, Cessation of Business, In the event a licensee ceases to do business at the licensed premises, other than temporarily for a period of not to exceed 45 successive days, for purposes of remodeling, or for purposes other than remodeling but with the prior written approval of the Local Liquor Control Commissioner, the number of authorized licenses in the particular class shall automatically be reduced by one at the time the licensee ceases to do business.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing the Class "XX-VG" liquor license category by one effective May 16, 2024, as a result of the licensee 3DH Hospitality LLC d/b/a Humo Smokehouse, 1000 N. Rohlwing Road, Suite 13, cessation of business.

Staff is requesting a waiver of first reading in order to reflect the current number of licenses in the "XX-VG" liquor license category.

ORDINANCE

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE NUMBER OF AVAILABLE LIQUOR LICENSES IN THE CLASS "XX-VG" LIQUOR LICENSE CATEGORY

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

<u>SECTION 1:</u> That, effective May 16, 2024, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by decreasing the entries relative to the Class "XX-VG" liquor licenses, contained therein, to read as follows:
