The petitioner has requested that first reading be waived.

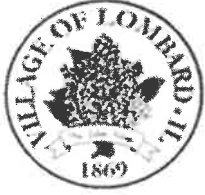

**SUBJECT:** **Title X1, Chapter 112, of the Lombard Village Code  
Afterthought Brewing Company – 844 N. Ridge Ave.**

As you are aware, the Village Board recently approved Ordinance 7813 granting a Class “SS” liquor license to Afterthought Brewing for its 218 E. St. Charles Rd. location. This location operates a brewery with an onsite taproom. Afterthought Brewing Company also operates a production-only brewery with sales to licensed retailers at 844 N. Ridge Avenue in Lombard’s North Industrial Park.

The owners of Afterthought Brewing have requested a liquor license for their Ridge Ave. location for the packaged goods sales of beer products manufactured onsite as well as beer products manufactured at their 218 E. St. Charles Rd. location associated with a membership club. The membership club is one where members pay a yearly membership fee to obtain apparel, glassware and the right to purchase exclusive beers. Beer will be ordered online, in advance by credit card. Filled online orders will then be picked up curbside at their 844 N. Ridge location with no customers entering the establishment.

Currently, Village Code does not have a liquor license classification that would fit Afterthought’s liquor license request. As a result of discussions with the applicant, staff requested that Village Counsel prepare an ordinance creating a new Class “FFF” liquor classification as well as amend other sections of Code within Chapter 112 which will be affected by the creation of the Class “FFF” liquor classification. The attached ordinance also would issue a Class “FFF” liquor license to Afterthought Brewing Company LLC d/b/a Afterthought Brewing Company located at 844 N. Ridge Ave.

The petitioner is requesting a waiver of first reading.

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE  
LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES  
AND A NEW CLASS “FFF” LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class “FFF” liquor license category, to read in its entirety as follows:

“Class “FFF” – “Packaged goods sales of beer products manufactured on the licensed premises, as well as beer products manufactured by the licensee at a location within the Village, other than the licensed premises, in response to phone and internet orders only, as part of a membership club, for pick-up by the membership club members at the licensed premises. The licensed premises shall not be open for entry by the public generally, but only for membership club members picking up the packaged goods beer, with said pick-up being done in a manner that does not require the membership club members to enter the licensed premises. All packaged goods beer that is picked up at the licensed premises shall have been sold pursuant to a sales transaction that is consummated in a manner that provides for the sales tax on such sales to come to the Village. Video Gaming, as provided for under the Illinois Video Gaming Act, shall not be allowed on the licensed premises”

**SECTION 2:** That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding language relative to a new Class “FFF” liquor license thereto, which shall read in its entirety as follows:

“Class “FFF” – 1”

The liquor license, as noted above, reflects the issuance of a new Class “FFF” liquor license to Afterthought Brewing Company, LLC d/b/a Afterthought Brewing Company, located at 844 N. Ridge Avenue, Lombard, Illinois.

**SECTION 3:** That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class “FFF” liquor license

category, to read in its entirety as follows:

“Class “FFF” – \$500.00”

**SECTION 4:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
