**ORDINANCE VACATING OF A PORTION  
OF ANN STREET AND ELIZABETH STREET RIGHT-OF-WAY**

WHEREAS, on the 20<sup>th</sup> of July, 2000, the President and Board of Trustees of the Village of Lombard approved by motion a vacation of public right-of-way described in Section 2 below, pursuant to appropriate and legal notice; and,

WHEREAS, said vacation requires adoption by the President and Board of Trustees by Ordinance.

NOW, THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: It is hereby determined that the public interest will be served by vacating a portion of Ann Street and Elizabeth Street right-of-way hereinafter described.

SECTION 2: That this ordinance is limited and restricted to the following described right-of-way:

THAT PART OF THE ANN STREET RIGHT OF WAY LYING EAST OF THE SOUTHERLY EXTENSION OF THE WEST LINE OF SAID LOT 24 IN BLOCK 11, AND LYING WEST OF THE SOUTHERLY EXTENSION OF A LINE 47.22 FEET EAST OF THE WEST LINE OF SAID LOT 15 IN BLOCK 6 IN ROOSEVELT CREST SUBDIVISION; AND

THAT PART OF THE EAST 1/2 OF THE ELIZABETH STREET RIGHT OF WAY LYING EAST OF AND ADJACENT TO THE WEST LINE OF SAID LOT 7 IN BLOCK 5 AND THE WEST 1/2 OF THE ELIZABETH STREET RIGHT OF WAY LYING WEST OF AND ADJACENT TO SAID LOT 2 IN BLOCK 12, LYING NORTHERLY OF THE SOUTH LINE OF VACATED 20' ALLEY, AND LYING SOUTH OF A LINE DRAWN FROM A POINT ON THE EAST LINE OF SAID LOT 28 IN BLOCK 11, 58.35 FEET SOUTH OF THE NORTHEAST CORNER OF SAID LOT TO A POINT ON THE EAST LINE OF SAID LOT 15 IN BLOCK 6, 58.35 FEET SOUTH OF THE NORTHWEST CORNER OF SAID LOT, IN ROOSEVELT CREST SUBDIVISION.

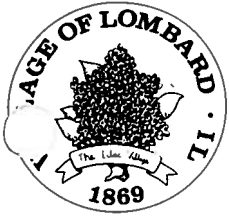

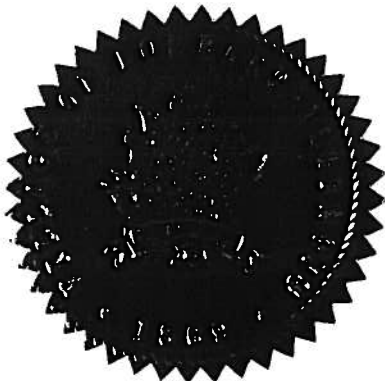



