### **Broadview Avenue Parking Restriction**

The Public Safety and Transportation Committee reviewed a resident request for a parking restriction on Broadview Avenue. The Committee reviewed the request at the March Public Safety and Transportation public meeting.

The resident stated that they have encountered occupied trucks that park on the street adjacent to the new Thorntons truck gas station. One residence (the requester), Thorntons Gas Station, and Lombard Assembly lie on this street. On February 21, the Village sent written notification of a proposed restriction to Thorntons Gas Station and Lombard Assembly, and no comments were received. To accommodate the business, residential, and non-profit land uses, a normal business hours restriction of Monday-Friday, 7 a.m. to 4 p.m., was proposed. Large trucks access the station from North Avenue via Broadview Avenue. These trucks (including semi-trailers) have large turning radii which may interfere with parked vehicles along Broadview Avenue. Due to these factors, Village staff recommended a business hours parking restriction on both sides of Broadview Avenue from North Avenue to the dead end.

During the March 7, 2018 meeting, the Public Safety and Transportation Committee voted to recommend the parking restriction in accordance with staff recommendation.

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Public Safety and Transportation Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Public Safety and Transportation Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VIII, paragraph (e) entitled "PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS" of the Lombard Traffic Code (Ordinance 1186) is amended to add the following restriction:

"Broadview Avenue from North Avenue to Dead End"

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
