Attached please find a contract and resolution pertaining to the design engineering services for the Great Western Trail Lighting Project from the east Village boundary (approx. Addison Street) to the west village boundary (approx. Rte 53) excluding the portion affected by the Great Western Trail Bridges (500 feet west of Grace Street to 850 feet east of St Charles Road).

Of the five short-listed firms that submitted proposals for this project, the Public Works evaluation team determined that ESI Consultants, Ltd. of Naperville, Illinois is the most qualified firm to serve as design engineer for the project.

Staff negotiated scope and fee with ESI Consultants. The not-to-exceed fee for design engineering services is \$89,194.12. This contract also includes assistance with funding research and grant applications.

Please present this agreement and resolution to the President and Board of Trustees for their review at their regular meeting of November 5, 2009. If approved, please have both signed copies returned to Engineering for further processing.
