## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

# BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class O" liquor license, contained therein, to read as follows:

Class "O" - 2

This decrease in the number of Class "O" liquor licenses reflects the termination of the Class "O" liquor license issued to Djont/Ept Leasing LLC d/b/a Embassy Suites Hotel, located at 707 E. Butterfield Road, due to new ownership of the hotel.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "O" liquor license, contained therein, to read as follows:

Class "O" - 3

This increase in the number of Class "O" liquor licenses reflects the issuance of a Class "O" liquor license to FelCor Lombard Lessee, L.L.C. d/b/a Embassy Suites Hotel, located at 707 E. Butterfield Road, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
