18/8 Fine Men's Salons-Lombard – 314 Yorktown Shopping Center**

The Village has received a request for a Class "V" liquor license from Duafe I, LLC d/b/a 18/8 Fine Men's Salons-Lombard located at 314 Yorktown Shopping Center to be able to serve beer, wine or champagne to a guest who is receiving a barber salon service.

18/8 Fine Men's Salons cater to male customers in an environment designed specifically for men. They offer handcrafted haircuts and styling, beard and mustache grooming, coloring services for both hair and beards, highlights, relaxers, facials, scalp treatments, MANicures and waxing services. 18/8 opened for business in Lombard on January 11, 2016.

Please note that approval of this request for a Class "V" liquor license is contingent on the approval of Legistar #170294 (the previous item on the agenda) which amends the Class "V" liquor description to include "full time barber salons".

The petitioner has requested that first reading be waived due to the Village Board's summer schedule.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "V" liquor license, contained therein, to read as follows:

Class "V" - 2

This increase in Class "V" liquor licenses reflects the issuance of a Class "V" liquor license to Duafe I, LLC d/b/a 18/8 Fine Men's Salons-Lombard located at 314 Yorktown Shopping Center, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
