On May 15, 2008, the Village Board approved a contract with Marcott Enterprises, Inc. for the Snow and Debris Hauling for FY 2009. In the bid documents was a provision to extend the contract for Snow and Debris Hauling for one additional year. Attached is a letter from Marcott Enterprises, Inc. indicating their willingness to provide a third year of service under the same terms, conditions and unit prices for an additional year.

To exercise the renewal option, the Village Attorney has stated that the Village Board must approve acceptance of the renewal. There is no need to sign a new contract. If approved by the Board, staff would send confirming letters with signature space for Marcott Enterprises, Inc. to accept extension of the contract. Marcott Enterprises, Inc. has provided good service during FY's 2009 and 2010.
