Due to the considerable number of snow and ice storms that we have experienced this winter, we have exceeded the \$20,000.00 cap for purchasing liquid calcium chloride. For FY2008 we purchased 32% liquid calcium chloride from Sicalco, Ltd. through the State of Illinois contract at a cost of \$0.52 per gallon.

I am requesting a waiver of bids and award of a contract to Sicalco, Ltd, in an amount not to exceed \$21,330.00 for the purchase of liquid calcium chloride for the current winter season. Please place this item on the agenda for consideration by the Village Board on March 20, 2008.
