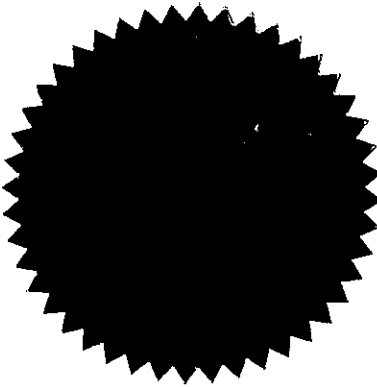

AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS
(BOT 02-19; SOUTHWEST CORNER RT. 53 & NORTH AVENUE)

WHEREAS, the following described unincorporated territory is completely surrounded by the Village of Lombard; and

WHEREAS, the following described unincorporated territory is comprised of less than sixty (60) acres of land area; and

WHEREAS, the Village of Lombard desires to annex the following described unincorporated territory pursuant to 65 ILCS 5/7-1-13; and

WHEREAS, notice of said contemplated annexation was published in the Spectator newspaper on May 17, 2002, said newspaper being a newspaper of general circulation within the territory to be annexed; a copy of the Publisher's Certificate relative to said publication being attached hereto as Exhibit "A", and made part hereof; and

WHEREAS, written notice of said contemplated annexation was sent by certified mail, return receipt requested, to the Milton Township Highway Commissioner, each member of the Board of Trustees of Milton Township and each property owner within the territory; an Affidavit of Service relative to said notice being attached hereto as Exhibit "B"; and made part hereof; and the return receipt cards being attached hereto as Exhibit "C"; and made part hereof; and

WHEREAS, all necessary legal requirements are in full compliance with the terms of 65 ILCS 5/7-1-13; and

WHEREAS, it is in the best interest of the Village of Lombard that the following described unincorporated territory be annexed thereto;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That the following described territory:

jurisdiction in the annexed territory and to the post office branches serving the annexed territory.



SECTION 5: This ordinance shall be in full force and effect from and after its passage and approval as provided by law.


