# POLICE

## VOICE OVER

In Lombard, our public safety facilities (some built 50 years ago) were not designed to meet modern safety standards and no longer have adequate space.

To continue providing the community with a high level of service to our community, our facilities must change to meet the current demands.

## VOICE OVER

When our police facility was built in 1974, it served Lombard well. Since that time, however, there have been many operational changes in policing and our staff has grown significantly. The building itself faces serious space constraints and does not meet the current code and accessibility requirements of a modern police facility.

The building is simply not designed for effective communication and sharing of information - a must for any modern department.

As a result, the department has been forced to adapt to a space that is outdated, overcrowded and not well suited for compliance with emerging best practices in law enforcement.

# CUT TO INTERVIEW:

## Police Officer Talking Points for Safety issues:

**Parking:** Police vehicles are currently parked in an open, unsecured area that the public has access to. This creates longer response times as the vehicles and equipment need additional time to warm up in the winter.

**Transfer of Detainees:** The sally port, a secure garage used for the safe transfer of detainees from a vehicle to the lockup area, and lacks the ability to accommodate multiple vehicles.

**Tight Hallways:** Corridors leading to the holding cells are very narrow at 4 feet wide. Officers need to have enough space to allow use of defensive tactics when necessary to safely restrain a detainee, which they don't currently have.

**Holding Cells:** Being able to isolate detainees so they can't talk to each other can be very important during an investigation. Our current holding cells have open fronts, and sound / noise separation is not possible. Lombard's holding cells do not meet Illinois Municipal Jail standards, which require solid doors.

# OPERATIONS

## VOICE OVER

Policing has vastly changed over the past 50 years. While the Village has done its best to adapt the building to suit the department's needs, there is simply not enough space to do so, and retrofits can only help so much.

In addition, the building's HVAC, electrical and plumbing systems are in need of significant and costly repairs.

Storage is a huge concern for the department; Evidence, Records and Equipment all require a lot of space.

Currently, evidence is stored in several locations throughout the building. A centralized evidence location with adequate space would make this work much more efficient and safe.

The department does not have a dedicated secure area to conduct computer forensics, something that wasn't as necessary 50 years ago.

# TRAINING

## VOICE OVER

Both police and fire departments are struggling across the country with recruitment and retention. Keeping staff in a comfortable, safe, appealing place to work is a high-priority for both the departments and the community.

With the increase in female officers, our facilities have failed to accommodate. The stations were designed at a time when there were very few females in the sworn ranks. Female officers now make up roughly 20% of the police force.

The department's men's and women's locker rooms have reached maximum capacity and no lockers are available for future female officers..

Both the number and size of lockers are inadequate.

# TRAINING

## VOICE OVER

Mandatory training required of police officers has greatly increased, and training spaces are needed to provide greater flexibility for classroom training, defensive tactics, simulator, and live fire scenario-based training.

Our Police department would benefit greatly from an adequate training room which could also be used for community engagement events.

# FIRE

## VOICE OVER

The Fire Department has identified a response gap in the central area of town. The industry standard of a four-minute response time to emergency calls is not being met in the gap area.

# CUT TO FIRE INTERVIEW:

Through a space needs analysis Station 45, built in 1986, was found considerably undersized for our current Fire Department operations.

The existing facilities do not properly accommodate the number of personnel, nor do they have appropriate facilities for female firefighters. Additionally, there is no room for growth; the department is at capacity.

Crowded quarters have a negative impact on personnel and have put the department at a disadvantage when recruiting new firefighters.

The existing facilities do not allow for the safe deployment of vehicles.

At Station 44, drivers must maneuver vehicles around one another inside the building before exiting to a call. This takes time and affects the department's overall response time.

Backing into a station and around vehicles creates safety concerns.

The Tower Ladder Truck (a specialized and important piece of equipment) is currently at a decentralized station, which creates a longer response time for this important vehicle that is needed at every fire in town.

A new centrally located fire station will allow emergency vehicles and personnel to get to calls faster, especially to the high-schools, and community parks.

Having a third station will also free up space in the existing stations. This will greatly ease overcrowding and allow for easier emergency vehicle movement and on-site training.

All of this means a safer Lombard.

## VOICE OVER

So, we have an outdated and undersized police station, overcrowded fire stations that cannot adequately meet optimal response times, nor do they help Lombard in attracting new firefighters and police officers in the current competitive recruiting environment. How do we solve these issues?

## VOICE OVER

Since 2008, the Village Board has been asking that same question. Multiple studies have been conducted, including facility needs and space needs studies which found that both fire and police are operating with much less space than is needed.

# VOICE OVER

A new fire station located where the police station currently is would drastically reduce our response times for life-saving services to all of Lombard, especially neighborhoods that are not near one of the existing stations

The first step in the Village Board's plan is to build a new police station at a central location in the community. Once complete, the focus will shift to the fire department to remodel both existing stations and build a new station on the site of the current police station.
