The (3) vehicles listed below are not needed by the Village. The first (2) are vehicles that were seized by the Police Department. The last (1) is a Fire Department vehicle (Unit # FP84) that has been replaced by another vehicle (Unit # FA2, 2008 Ford Escape). Staff is requesting BOT approval to sell these vehicles. Section 3: The Village Manager is hereby authorized and may direct Obenauf Auction Service to advertise the sale of the aforementioned personal property in a newspaper published within the community before the date of said public auction.

<u>Section 4:</u> No bid which is less than the minimum price set forth in the list of property to be sold shall be accepted.

<u>Section 5:</u> The Village Manager or his designee shall cause to be transferred any titles or other legal documents pursuant to the sale.

Section 6: This ordinance shall be in full force and effect from and after its adoption and approval as provided by law.
