SUBJECT: **Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code
Shahi Banquets – 530 E. North Avenue**

In April, 2015 Shahi Banquets located at 530 E. North Ave. was issued a Certificate of Occupancy/Zoning Certificate to operate as a Restaurant under the B4 Zoning Classification and has been operating as a banquet facility since that time. The Village has received a request for a liquor license from Usmania Foods, Inc. d/b/a Shahi Banquets.

Attached is an ordinance increasing the Class "K" liquor license category by one. The petitioner has requested that the license become effective concurrent with the June 1, 2016 liquor licensing term, consequently, they have requested a waiver of first reading.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That, effective June 1, 2016, Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "K" liquor license classification, contained therein, to read as follows:

Class "K"- 3

This increase in Class "K" liquor licenses reflects the issuance of a Class "K" liquor license to Usmania Foods, Inc. who will be operating the business commonly known as Shahi Banquets located at 530 E. North Avenue, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
