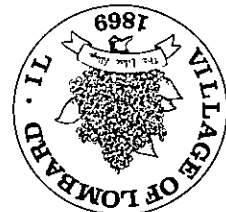

The Transportation and Safety Committee, at their April 2nd meeting, voted unanimously to approve the following item:

070052--No parking: A parking issue was brought forward by the Cruise Nights Committee. Limiting parking to one side of the street on specific streets will provide additional space for emergency vehicles and ease traffic flow during the Cruise Night events. Staff requests a change to the Village Traffic Code to post "No Parking Cruise Nights 5:00 p.m. - 10:00 p.m." at the following locations:

East side of Lincoln Ave. from St. Charles Rd. to Grove St.
West side of Elizabeth St. from St. Charles Rd. to Eugenia Ave.
North side of Grove St. from Park Ave. to Lincoln Ave.

New Schedule

SCHEDULE VIII (G) - PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN

STREETS

In accordance with Section 10-13-3 and when signs are erected giving notice thereof, no person shall, at any time, park a vehicle between the hours of 5:00 p.m. - 10:00 p.m. Cruise Nights upon any of the following streets or parts of streets:

- East side of Lincoln Ave. from the north curb line of St. Charles Rd. to the south curb line of Grove St.
- West side of Elizabeth St. from the north curb line of St. Charles Rd. to the south curb line of Eugenia Ave.
- North side of Grove St. from the west curb line of Park Ave. to the east curb line of Lincoln Ave.

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

ORDINANCE NO. _____

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VIII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS be amended to add the following thereto:

(t) In accordance with Section 10-13-3 and when signs are erected giving notice thereof, no person shall, at any time, park a vehicle between the hours of 5:00 p.m. - 10:00 p.m. during Cruise Nights upon any of the following streets or parts of streets:

Name of Street From To

Lincoln Ave. North curb line of St. Charles Road South curb line of Grove Street

Elizabeth Street West side of St. Charles Road South curb line of Eugene Ave.

Grove Street North side of West curb line of Park Avenue East curb line of Lincoln Avenue

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
