WHEREAS, Trustee \_\_\_\_\_\_ and Trustee \_\_\_\_\_\_ have indicated that, if appointed Acting Village President, each would remain as Acting Village President, and would not exercise the authority granted by 65 ILCS 5/3.1-10-50(d), to resign as Trustee and become the Village President; and

WHEREAS, Trustee \_\_\_\_\_ and Trustee \_\_\_\_\_ have indicated their willingness to share serving as the Acting Village President, with each serving as Acting Village President for a portion of the time period between now and when the new Village President, elected at the April 9, 2012 election, is sworn in at the May 2, 2013 Village Board meeting; and

WHEREAS, it is important to, and in the best interests of, the functioning of the Village that an Acting Village President be elected by the Trustees;
