SUBJECT: Ordinance Amending Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code - Lombard Moose Lodge, 328 W. Roosevelt Road

Lombard Moose Lodge located at 328 W. Roosevelt Road holds a Class "T" liquor license. Over the years, the name that appears on their liquor license has appeared as:

- Lombard Moose Lodge 2350, Loyal Order of Moose d/b/a Lombard Moose Lodge
- Lombard Lodge 2350 d/b/a Lombard Moose Lodge
- Lombard Moose Lodge 2350 d/b/a Lombard Moose Lodge

as well as other slight name variations. In an effort to be accurate and consistent, staff contacted the keyholder of the Moose Lodge to confirm the corporation and licensee name. After verifying that there has been no ownership change, it was determined that the name discrepancies appear to be inadvertent.

Attached is an ordinance decreasing and increasing the number of Class "T" liquor licenses by one, to reflect the correct corporation and licensee name as verified by the keyholder of the Lombard Moose Lodge, as well as how it appears on the Secretary of State's website.

Staff is requesting a waiver of first reading due to the cancellation of the June 5, 2014 Village Board meeting.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "T" liquor license category, contained therein, to read as follows:

Class "T" - 2

This decrease in the number of Class "T" liquor licenses reflects the correction of the licensed entity relative to the Class "T" liquor license issued to the Lombard Moose Lodge and the termination of the Class "T" liquor license issued to Lombard Moose Lodge 2350, Loyal Order of Moose d/b/a Lombard Moose Lodge.

SECTION 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "T" liquor license, contained therein, to read as follows:

Class "T" - 3

This increase in the number of Class "T" liquor licenses is a result of authorizing a new license to the Lombard Lodge 2350 Loyal Order of Moose d/b/a Lombard Moose Lodge located at 328 W. Roosevelt Road, Lombard, IL.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
