ORDINANCE NO.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by deleting the language contained therein, relative to the following liquor license categories:

Class "E-I"

Class "FF"

Class "O-II"

Class "Q"

Class "S"

Class "Y-II"

SECTION 2: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by revising the reference therein to "Class "E-II"," to read "Class "E"," and the holder of any existing Class "E-II" liquor license shall be issued a new Class "E" liquor license to replace the Class "E-II" liquor license.

SECTION 3: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by revising the reference therein to "Class "O-I"," to read "Class "O"," and the holder of any existing Class "O-I" liquor license shall be issued a new Class "O" liquor license to replace the Class "O-I" liquor license.

SECTION 4: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by revising the reference therein to "Class "Y-I"," to read

"Class "Y"," and the holder of any existing Class "Y-I" liquor license shall be issued a new Class "Y" liquor license to replace the Class "Y-I" liquor license.

SECTION 5: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by deleting the language contained therein relative to the following liquor license categories:

Class "E-I"

Class "FF"

Class "O-II"

Class "Q"

Class "S"

Class "Y-II"

SECTION 6: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the reference therein to "Class "E-II" -1," to read "Class "E" -1".

SECTION 7: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the reference therein to "Class "O-I" -3," to read "Class "O" -3".

SECTION 8: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the reference therein to "Class "Y" -1".

SECTION 9: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by deleting the language contained therein relative to the following liquor license categories:

SECTION 10: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by revising the reference therein to "Class "E-II" -\$1000," to read "Class "E" -\$1000".

SECTION 11: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by revising the reference therein to "Class "O-I" -\$2000," to read "Class "O" -\$2000".

SECTION 12: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by revising the reference therein to "Class "Y-I" -\$500," to read "Class "Y" -\$500".

SECTION 13: That Title 11, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the reference therein to "all Class A/B-I, A/B-II, A/B-III, A/B-IV, C, D, E-I, E-II, I, K, L, M, O-I, O-II, R, T-I, T-II, X and Z liquor license holders," to read, "all Class A/B-I, A/B-II, A/B-III, A/B-IV, C, D, E, I, K, L, M, O, R, T-I, T-II, U, X and Z liquor license holders."

SECTION 14: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
