## **BACKGROUND/POLICY IMPLICATIONS:**

The attached ordinance amends the Village Code concerning the mileage reimbursement rate for ambulance service increasing from \$5.53 to \$5.65 per mile for 2004. This rate is established in accordance with the Medicare reimbursement fee schedule established by the federal government and became effective January 1st. For this year, only the mileage reimbursement rate will change. Our current fees for BLS, ALS Level I, ALS Level II and ALS (Treat/No Transport) remain unchanged for calendar year 2004 although the reimbursement formula will change to provide a higher reimbursement to the Village from Medicare.

Since the new mileage reimbursement rate is currently in effect, waiver of first reading is requested.

## AN ORDINANCE AMENDING TITLE 9, CHAPTER 91, SECTION 91.21 OF THE LOMBARD VILLAGE CODE IN REGARD TO EMERGENCY MEDICAL SERVICES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, as follows:

Section 1: That Title 9, Chapter 91, Section 91.21(B) of the Lombard Village Code is amended to read in its entirety as follows:

"(B) In addition to the fees set forth in subsection (A), a mileage fee shall be charged in regard to Emergency Medical Transportation Service provided by the Village at the rate of \$5.65 per mile."

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
