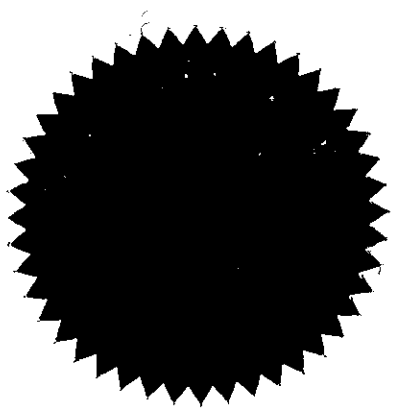

ORDINANCE 4379

AN ORDINANCE AMENDING TITLE 11, CHAPTER 122 OF THE LOMBARD VILLAGE CODE IN REGARD TO MASSAGE ESTABLISHMENTS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 122, Section 122.01 of the Lombard Village Code is amended by adding the following to the end of the definition of "CERTIFIED MASSAGE THERAPIST" contained therein:

"Said educational institution must be licensed under the Private Business and Vocational Schools Act, 105 ILCS 425/1 et seq. if located within Illinois, or a similar statute if located outside of the state."

SECTION 2: That Title 11, Chapter 122, Section 122.03(F) of the Lombard Village code is amended by adding the following to the end thereof:

"Notwithstanding the foregoing, a temporary permit may be issued, for less than a one (1) year period, pending the results of the processing of the fingerprints, at which time said non-temporary permit shall expire and a non-temporary permit shall either be issued or denied."

SECTION 3: That Title 11, Chapter 122, Section 122.10(B) of the Lombard Village Code is amended by adding a new subsection (12) thereto which shall read in its entirety as follows:

"(12) A certificate of insurance evidencing professional (malpractice) liability insurance, covering all masseurs and masseuses that will be working for the Massage Establishment, in an amount of not less than five hundred thousand and no/100 dollars (\$500,000.00) per occurrence."

SECTION 4: That Title 11, Chapter 122, Section 122.10(C) of the Lombard Village Code is amended by adding the following to the end thereof:

" , along with a copy of the license issued to said educational institution (or documentation evidencing said licensing) under the Private Business and Vocational Schools Act, 105 ILCS 425/1 et seq., if said educational institution is located in Illinois, or a copy of a similar state issued license if said educational institution is located outside of Illinois."

SECTION 5: That Title 11, Chapter 122, Section 122.22(c) of the Lombard Village Code is amended by adding the following to the

end thereof:

"Notwithstanding the foregoing, a temporary permit may be issued, for less than a one (1) year period, pending the results of the processing of the fingerprints, at which time said non-temporary permit shall expire and a non-temporary permit shall either be issued or denied."

SECTION 6: That Title 11, Chapter 122, Section 122.21(H) of the Lombard Village Code is amended by adding the following to the

end of the second sentence contained therein:

" , along with a copy of the license issued to said educational institution under the Private Business and Vocational Schools Act, 105 ILCS 425/1 et seq., if said educational institution is located in Illinois, or a copy of a similar state issued license (or documentation evidencing said licensing) if said educational institution is located outside of Illinois."

SECTION 7: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in

pamphlet form as provided by law.
