Staff is requesting a waiver of first reading in order to bring the number of licenses in this liquor license category current effective July 1, 2021.

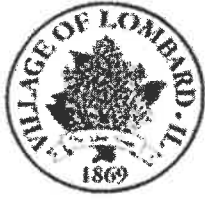

Alcoholic Beverages
Voluntary Non-Renewal of Liquor License**

In accordance with Village Code, liquor licenses are renewed on a semi-annual basis. Village staff is completing the renewal process for the July 1 through December 31, 2021 licensing term. Staff has been notified that LFJ, LLC d/b/a Lawrence's Fish & Shrimp located at 908 E. Roosevelt Road will voluntarily not be renewing their liquor license for the upcoming licensing term.

Attached is an ordinance decreasing the number of entries in the "A/B-I" liquor license classification by one, effective July 1, 2021, to account for their voluntary non-renewal.

Staff is requesting a waiver of first reading in order bring the number of entries in each liquor classification current.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE
NUMBER OF AVAILABLE LIQUOR LICENSES IN THE CLASS
“A/B-I” LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That, effective July 1, 2021, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by decreasing the entries relative to the Class “A/B-I” liquor licenses, contained therein, to read as follows:

Class “A/B-I” – 5

SECTION 2: That, effective July 1, 2021, the decrease in the number of Class “A/B-I” liquor licenses set forth in Section 1 above is a result of LFJ, LLC d/b/a Lawrence’s Fish & Shrimp voluntarily not renewing their liquor license for the July 1, 2021 liquor licensing term.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
