TITLE: An Ordinance amending Schedule XII of the Lombard Village Traffic Code in regard to an increase in permit parking rates for Special Village Parking Lot A North Broadway Avenue.

BACKGROUND/POLICY IMPLICATIONS:

Special Village Parking Lot A North Broadway Avenue has recently been improved and will be completed in October, 2005. Taking the cost of the improvements as well as ongoing maintenance costs into account, staff recommends that the permit parking rate be increased to \$40.00 per six month permit period or \$6.75 per month for a permit period of less than six months.

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule XII (a) of the Lombard Traffic Code entitled PERMIT PARKING ZONES is amended to add the following thereto:

Special Village Parking Lot A	\$40.00/6 month period
North Broadway Avenue	\$6.75 per month/less than 6 months

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
