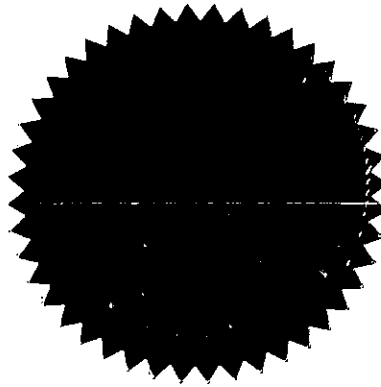



**ORDINANCE 5261**  
**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,**  
**SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN**  
**REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES**  
**OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:**

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor license, contained therein, to read as follows effective April 1, 2003:

Class "U" - 4

This decrease in Class "U" liquor licenses reflects the sale of the assets of Amazing Graze Ltd. and the termination of the Class "U" liquor license issued to Amazing Graze Ltd. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor license, contained therein, to read as follows:

Class "U" - 5

This increase in Class "U" liquor licenses reflects the issuance of a Class "U" liquor license to Amazing Graze Enterprises who will be operating the business commonly known as Amazing Graze, 18 W. St. Charles Road, Lombard subject to the condition set forth in Section 3 below.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.


