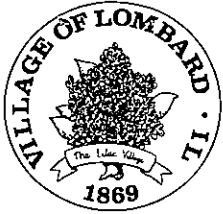

The FY 2008 budget includes replacement of FR52, a 1988 Aerial Platform Fire Truck. The bid results are as follows:

Pierce Manufacturing Inc. Appleton, WI.	\$908,438	\$15,000	\$893,438

Public Works received one sealed bid from Pierce Manufacturing. The bid price for the 2007 aerial platform fire truck is \$908,438 less a trade-in allowance of \$15,000 equals a net total bid of \$893,438. The budgeted amount for this vehicle is \$950,000 minus \$100,000 salvage for the surplus fire truck or \$850,000 which makes this vehicle \$43,438 over budget. Since there are only two manufacturers of this type of vehicle acceptable to the fire department, Pierce and E-ONE, and Pierce is the only one which submitted a bid I recommend awarding the contract to Pierce, without the trade-in option. It has been our experience that trade in prices offered by fire apparatus manufacturers are lower than what a broker could get for the same vehicle. This surplus fire truck can be sold through a broker for considerably more reducing the budget deficit for this vehicle.

I recommend the award of a contract to Pierce Manufacturing of Appleton, WI. in the amount of \$908,438. The ordinance declaring the village's fire truck surplus will be submitted to the BOT as soon as the marketing period is over. Please submit this item to the Village Board for their consideration at the November 2, 2006 meeting.
