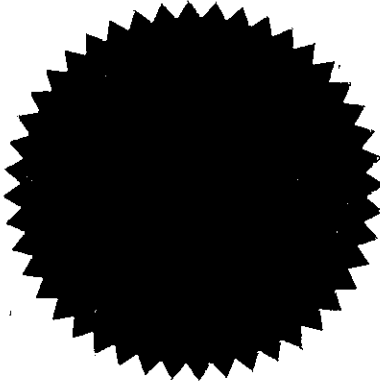

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.12 (A) of the Lombard Village Code is amended by adding a description for a new Class "Y" liquor license which shall read in its entirety as follows:

"Class "Y" - Package sales of Italian beer and Italian wine as an adjunct to a delicatessen selling primarily Italian food items with less than 3000 square feet of interior space, but with not less than 450 square feet of said space devoted to a deli area for the sale of fresh and/or prepared on the premises food items, and with not less than 1200 square feet of said space devoted to a kitchen area, not accessible by the public, for use in the preparation of prepared foods sold in the deli area. The area set aside for liquor sales and storage shall not exceed five percent (5%) of the non-kitchen floor area of the delicatessen."

Section 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the list of authorized licenses to add a new class which shall read as follows:

"Class "Y" - 1"

Section 3: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding an entry relative to a Class "Y" liquor license which shall read as follows:

"Class "Y" - \$500.00"

Section 4: This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.




