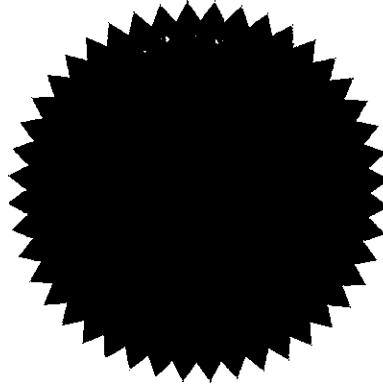

ORDINANCE NO. 5535

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule I of the Lombard Traffic Code (Ordinance 1186) entitled ALTERED MAXIMUM SPEED LIMITS be amended to add the following thereto:

Name of Street	From	To	Max Speed
Fairfield Avenue	Roosevelt Rd.	Wilson Ave.	25 MPH
Maple Street	Vance Street	Addison Street	25 MPH

Section 2: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STRETS be amended to delete the following therefrom:

Name of Street	Shall Stop At	Name of Street
Hickory Street	"	Edson Avenue

Section 3: That Schedule III of the Lombard Traffic Code (Ordinance 1186) entitled STOP INTERSECTIONS be amended to add the following thereto:

Edson Avenue and Hickory Street

Section 4: That Schedule XX (f) of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING during the hours of 3:00 p.m. to 3:30 p.m. on school days be amended to read in its entirety as follows:

Name of Street	From	To
Green Valley Drive	east curb line of	a point 550 feet east
North side	Green Valley Drive	West

Section 5: That Schedule V of the Lombard Traffic Code (Ordinance 1186) entitled PRRFERENTIAL STREETS be amended to add the following thereto:

Lodge Avenue will yield to Emerson Avenue
Lewis Avenue will yield to Emerson Avenue

Section 6: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.






