

**ORDINANCE NO. 6285**

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

Martha St., west side	Ash St.	Parkside Ave.
Garfield St., west side	Washington Blvd.	Illinois Prairie Path
Randolph St., north side	Charlotte St.	Martha St.
Elm St., north side	Craig Place	Grace Ave.
Craig Place, west side	Washington Blvd.	Parkside Ave.
Stewart Ave., west side	Washington Blvd.	Parkside Ave.
Lombard Ave., west side	Washington Blvd.	Parkside Ave.

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
