## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class A/B II" liquor license, contained therein, to read as follows:

Class "A/B II" - 10

This decrease in Class "A/B II" liquor licenses reflects the termination of Flat Out Crazy LLC d/b/a Flat Top Grill and the termination of the Class "A/B II" liquor license issued to Flat Out Crazy LLC in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B II" liquor license, contained therein, to read as follows:

Class "A/B II" - 11

This increase in Class "A/B II" liquor licenses reflects the issuance of a Class "A/B II" liquor license to FT Acquisitions, LLC who is operating the business commonly known as Flat Top Grill located at 305 Yorktown Center, Lombard, IL.
