FY 2016 Off-Season Road Salt Purchase

The 2015-2016 winter season has required the Village to use approximately 1300 tons of the road salt supply that it had in reserve

The Village has tried to maintain a reserve of salt for winters such as this past one and foregoing inflated salt prices. Area municipalities that purchased salt for this last winter season had to pay highly inflated prices for salt. Some of the prices paid ranged from \$88 to \$126 per ton.

The Village board authorized the participation in DuPage County Department of Transportation's salt bid. Bids for this contract were opened April 20, 2016. Compass Materials was the lowest bidder with a per ton cost of \$56.35 and will be the provider of bulk road salt for the County's contract.

Staff is requesting the purchase of 1300 tons of salt to replenish the salt that was used during this last winter season.

Salt purchase of \$73,255.00 will be paid for by the MFT fund 420.730.730.73310
